Charlene versus the Volcano

Presented by: Charlene L Wardlow, California Division of Oil, Gas, and Geothermal Resources.

Abstract: Charlene Wardlow, Northern District Deputy and Geothermal Program Manager for the CA Division of Oil, Gas, and Geothermal Resources, was deployed by the Hawaii Emergency Management Agency to serve on the Geothermal Task Force during the Kilauea eruption to assist in securing the geothermal wells at the Puna Geothermal Venture project in the East Rift Zone. Charlene will describe her 12 challenging days on the island working adjacent to an active volcanic eruption.



Biography: Charlene is the Northern District Deputy and Geothermal Program Manager for the California Division of Oil, Gas, and Geothermal Resources. She has a BS in geology and an MS in Petroleum Engineering from the New Mexico Institute of Mining and Technology in Socorro, NM. She has over 3 decades of experience in the geothermal industry including 23 years at The Geysers involved in oversight of wellfield and power plant operations. She spent 10-years working for Ormat Technologies, Inc. focused on developing new geothermal projects in California with an emphasis on exploration activities, drilling and well operations, and the power plant construction and operations. She supported environmental compliance for existing projects and coordinated permitting and compliance with the local, state and federal agencies, elected officials including community and public outreach.
